





# EDITORIAL

### verlooked

S. Dov Sydney, International Editor



representing dentistry's n foremost contributors since 1928, our College has earned the distinction of being the world's oldest and largest international dental honorary society. Ironically, the majority of the dental profession (let alone the lay public) has only a vague appreciation for the rich tradition and global impact of the ICD. This unfortunate condition along with our relatively small membership leads to the misunderstanding that the Fellowship recruitment model is designed to somehow maintain a restricted number of arbitrarily selected candidates.

While the presumption is wrong, the fact remains that many of the world's best and brightest, truly dedicated, humanitarian and unquestionably deserving dentists have been overlooked in not receiving our profession's most distinguished invitation.

Fellows whose primary motivation for involvement in our organization is the collegial benefits may not be concerned about widening membership in the College. For them, the enduring fraternal relationships are value enough to sustain affiliation with the College. But maintaining camaraderie alone, albeit a College objective, will not insure and more significantly will not enhance the exceptional position the ICD has merited in its eighty five years of existence.

To be faithful to the goals of the College and in particular to insure the continuity and expansion Many of the world's best and brightest, truly dedicated, humanitarian and unquestionably deserving dentists have been overlooked in not receiving our profession's most distinguished invitation.

of the College's humanitarian commitments around the world, we must endorse a global awareness campaign to increase the understanding of the ICD. Concomitantly, we should maximize the infusion of properly vetted, peer-reviewed candidates who demonstrate substantial promise of contributing to the College and dentistry.

Fellows concerned that a significant rise in the quantity of new members might suggest a relaxation in the quality of potential candidates need not be worried. As has been our tradition, only the most worthy will continue to be honored with the invitation of Fellowship. The difference is that with a concerted effort, we will embrace more of those deserving recognition. Furthermore, even in the unlikely scenario of quadrupling our current membership, the ICD's eminent constituency would still only account for a singledigit percentage of all dentists worldwide.

When properly chosen, motivated and mentored each inductee embodies unlimited possibilities to expand the College footprint, broadening opportunities to serve, embolding the impact on humanity in every corner of the world, and not lessen but, to the contrary, enrich with greater diversity and energy, collegiality in our home nations and beyond.

As a co-founder of the Smile Charity Foundation for the dental treatment of the disabled people in Korea, he looks forward to sharing the technology and administrative skills required for such a program throughout the world. In May of this year, Dr. Yang will be hosting World President Dr. Leon Aronson during his visit to Seoul, Korea, where he plans to arrange for Dr. Aronson's participation in the Board of Directors meeting and Initiation Ceremony. In addition, Dr. Yang looks forward to guiding President Aronson through the dental hospital for the disabled people. He plans to show him how the hospital is administered, in hopes of spreading this knowledge to other College Sections and Districts.

### Dr. Kenneally Elected Vice President Will Lead College in 2015



r. Joseph R. Kenneally, from Kennebunk, Maine, USA, was elected Vice President of the International College of Dentists and will ascend to the presidency of the College in 2015. He has served the ICD in many capacities since his initiation in 1995, including Councilor of the College since 2006, while concurrently serving as his State's Deputy Regent, then District's Vice Regent. Presently, he is a Section I Regent. He has served the ICD College

at Large as the webmaster of the website and Chair of the Information Technology Committee. He was Editor of the Section I, District 1 "District News" for its first seven years of publication. He is currently enjoying his participation in his Section's Applied Strategic Planning process.

Dr. Kenneally is a past President of the Maine Dental Association, a past Vice President of the American Dental Association, and a current Trustee of his undergraduate alma mater, the University of New England.

Dr. Kenneally hopes to guide the College in the development of a strategic plan with a shared mission statement to guide it during this time of transition. "Now that the College has separated its administrative functions from those of Section One, it has the opportunity to explore all aspects of the organization, including its means of financing, its governance, and its purpose. I hope to help the College to achieve increased prominence and visibility, as the premier international dental organization in the world."

Joe has been involved in many humanitarian projects, including service on the Advisory Board of the National Museum of Dentistry; service to the National Foundation of

Dentistry for the Handicapper's program, Donated Dental Services; and as a Co-Founder of the Dental Wellness Center of the Biddeford (Maine, USA) Free Clinic, which provides dental services to indigent patients at no cost. He has made numerous presentations to dental societies, study clubs, and other organizations on the subjects of CAD/CAM

restorations, temporomandibular joint disorders, and dental jurisprudence.

Dr. Kenneally was the 2010 recipient of the James W. Etherington Award for lifetime service to the dental profession in the New England states of the USA, and the 2002 recipient of the Section I award "Distinguished Deputy Regent".

Dr. Kenneally is looking forward to holding office along with his old friend, Leon Aronson, with whom he served on the American Dental Association Council on Membership, and Woong Yang, who was a fellow Tufts student during their dental school days. His spouse Dr. Lisa Howard is also a Fellow of the ICD, and between them they have four children, the youngest two of whom are in college.

### Editor Dov Sydney Expands **College Communications**




his has been a very dynamic period in communications for the College beginning with the appointment of Editor Sydney to the new staff position of Director of Communications. The combined tasks allow the College to work efficiently on many new programs designed to improve and expand communications.

In addition to the redesigned *Globe* and E-news letter The College Today, the website has been reformatted

with many innovative and user-friendly features. A new e-mail message called College Update is a date-specific blast email that provides all Fellows with valid email addresses ontime, sensitive news. The first College Update distribution

announced the results of the elections for the 2013 College Officers, immediately after the International Council meeting in San Francisco. Before many Councilors had arrived back to their home countries, local Fellows had already received news of the election results

Topping the list is a video presentation utilizing our first YouTube entry featuring an address by President Leon Aronson.

The Media Center is an exciting development on the website and was created for Fellows, the wider dental community, and the lay public. As part of the Media Center program, Press Releases are regularly sent out to major dental organizations around the world, as well as health journalists and publications that target the dental community.

Other than our print-based annual journal The Globe, all ICD College at Large publications are delivered either through access to the website or via our recently acquired and highly

successful e-mail server. We are now capable of reaching the entire College e-mail list within two minutes of release. This means that wherever a Fellow is in the world, regardless of inclement weather or other limitations and delays that would hamper physical delivery, he or she will receive his College e-mail message at the same time as every other Fellow in the world at the instant it is released.

In 2012, over 30,000 e-mail messages were generated from the Council Office. The College e-mail list is constantly updated based on feedback received from individual Fellows and Section Registrars. The Council Office recently identified and contacted Fellows who participated in the e-mail communications survey and did not receive *The Globe*. Fellows who have not received any of the ICD communications are asked to inform the Council Office and provide current e-mail and postal addresses.

### Why be ICD Treasurer? Dr. Clive Ross Answers



s this a question of "fools rush in where angels fear to tread" ignorance, overconfidence or recognition that what we do is worthwhile? Given the time and anxiety, does the broad satisfaction with what the College stands for and achieves, outweigh these hindrances?

Being treasurer of an international organization carries its own set of obligations and responsibilities. A Treasurer has to protect the financial

resources of the organization as a prime responsibility, while ensuring that the organization is capable of meeting its obligations as set out in its objectives and the wish of its members. In our case, this is Fellows of the College throughout the world, regardless of their political, economic or social circumstances.

#### The Treasurer's Term

Unlike the line officers who are elected annually for a oneyear term, the Treasurer is elected annually for a maximum term of four years- for good reason. Financial management is not a 12 month exercise. Good financial management is required to ensure medium and long term stability and security, to enable development and expansion of the College objectives, to provide a roadmap for emerging initiatives and to act as a catalyst that empowers the Executive and the Council at Large to do its elected job.

#### Meeting the Challenge

Of course there are challenges in this. Sections and Regions, which represent Fellows around the world with differing needs and ideas, must all be supported.

The work they are doing is amazing, more often than not understated and not attention seeking, but nonetheless hugely appreciated and respected. In many circumstances this work is carried out with limited funding but enormous commitment and enthusiasm, often at their own personal expense, with no expectation of recognition other than knowing that the people they are helping are deserving and needy.

#### Maintaining Stability

Stability in managing the International College is not simple. Our currency and income is based on the US dollar,

which presents difficulty with today's currency fluctuations. We have to balance our enthusiasm or frustrations and our wish to do more against the reality that individual Fellows are the "funders" of the College, and whatever we do or aspire to do is with their contribution.

A consequence of this is to carefully assess the impact of any rising of dues to balance a "wish list" against hard economic circumstances. Yet we know this must be done within a cautious, regular timetable if the College is to remain true to its cause.

So the role of the treasurer in the ICD is to add a voice, both cautious yet optimistic, that contributes to the College development and effectiveness, and facilitates the outstanding contribution that our Fellows around the world are making. What a privilege.

### ews from the Council

### *Communication Survey Provides Direction for the Future*

For the first time, a full global membership, blast e-mail survey was performed. The results were excellent in comparison to industry standards and provided reliable, statistical information that will be of value in both short and long-term College planning. The nearly 1,000 participants accounted for more than a representative sample, suggesting that the potential for accurate analysis is formidable.

A summary of the data includes:

- "Years in the College" was evenly distributed across the board ranging from less than five years in the College to greater than 20.
- *The Globe*'s most read segments; Section Reports (39%) and Impact features (27%).
- *The Globe* readers had a nearly 50-50 preference for print verses electronic version.
- The ICD.org website is visited frequently or infrequently by 75% of the Fellows; 21% have never visited the website.
- *The College Today* E-news letter (TCT) is read in part or completely by 63% of the Fellows.
- Fellows would like to receive *The College Today* quarterly (57%) or semiannually (33%).

While there is ongoing evaluation involving the full International Council, the Executive Committee as well as the Communications and IT committees certain conclusions have clearly been established already and are being acted upon. It had been previously thought that the younger members would be more likely to use e-mail and other electronic media, but in fact the results demonstrated that their use is evenly spread among all age groups. The majority of the College will be able to benefit by increasing electronic-based media.

The survey identified the TCT as highly appreciated and a desire for it to be released more frequently. Therefore, TCT schedule has been increased. In addition, an e-mail based, timesensitive news brief called the *College Update* reported on the results of the international officers elections in San Francisco, within 24 hours of the results. The College is also evaluating an electronic-interactive version of *The Globe* and ways to increase traffic to the website by enhancing both the relevance and available resources.



### College Logo and Key Guidelines

An Editors Task Force Subcommittee developed guidelines to assist Fellows and Sections in making decisions on the appropriate application of the new ICD logo and the College Key. Permission to use College symbols is extended exclusively to recognized divisions and subdivisions of the College, as well as individual Fellows with valid memberships.

The committee, chaired by College Editor Dov Sydney, found that by restricting the Key to more formal or unique applications, we elevate and honor its revered status in the ICD, while encouraging the new logo to be applied to more informational, communicational and informal applications.

The structure of the program is designed so that benefit of some kind was gained not only by the ICD but also by the Diamond Sponsors. 
#### Inaugural Sponsors in 2012

The most important element in securing a Diamond Sponsor is to know and have contact with the decision makers of the company considering sponsorship. This is often difficult to elicit, but the information should be available from local and regional representatives. It is also imperative to establish the time that a potential sponsor's budget for aid starts during the year.

All companies have a footprint for sales and marketing and most have a desire to give aid where they perceive that it will be well spent and administered. It is the College's responsibility to achieve high benefit-to-cost ratios in its multiple educational and humanitarian projects worldwide.

The ICD is in a unique position as the largest honorary dental organization in the world to enable these projects to be carried out effectively, but in order to maintain its pre-eminent position it must, in the 21st century, obtain commercial sponsorship. Every Fellow has a role to play. Please be proactive and see what you can do, but be persistent and don't take NO for an answer.

# ew Growth, New Initiatives

### John V. Hinterman, Secretary General



he year 2012 was pivotal for the International College of Dentists. It was a very busy year, full of new initiatives and growth. We experienced exceptional growth in International Section XX, with new Fellows and new leadership in several ICD Regions. The year began with extensive travel on my part, and ended with the total reorganization and relocation of the Council Office to the State of Michigan where I reside. We are now well-positioned for continued success.

### History in the Making

In January, a historic new beginning occurred for the ICD in Africa when I presided over the continent's first Initiation Ceremony in Accra, Ghana. In April I traveled to Southeast Asia to visit the Regents of ICD Malaysia, Singapore and Vietnam. In Ho Chi Minh City, the Vietnam ICD Region 31 was reactivated and 78 new or returning Fellows were welcomed into the ICD worldwide community of dentists. This burst of enthusiasm for ICD growth in new areas is a promising sign of good things to come.

### **Council Office Transition**

The Executive Committee meeting in Vancouver, British Columbia, Canada, decided that management of College at Large business would be more efficient if the Secretary

General was located in the same office as the Council Office Administrator. This arrangement is the preferred business model for the future. Planning and relocating both employees and offices from Rockville, Maryland, USA, to Flint, Michigan, USA, became a major undertaking during the past year. Conducting College business as usual, without interruption, was the first priority. Accomplishing the task without major financial impact was also accomplished. The new Council Office opened as scheduled on December 1<sup>st</sup> in Flint, Michigan.

### Connecting the College Electronically

For many years the ICD College at Large has sought to improve communications with all ICD Fellows around the world. The goal of connecting all Fellows by means of a unified Data Base Management System (DBMS) proved to be an elusive dream. Suddenly in 2012, a breakthrough occurred. The ICD has adopted the QuickBase DBMS (Intuit Corp), which is presently being deployed one ICD Section at a time. Imagine the complexity of bringing together the demographically diverse global membership of ICD Fellows into a single association management system. Differences in languages, customs, and currencies can be overcome using modern data base technology. The new ICD system will produce accurate and updated membership records for improved communications and record keeping.

### ICD Worldwide Charitable Fund

During the 2012 Annual Meeting in San Francisco, the International Council passed the following motion: The College at Large shall develop and seek the approval of a United States Government IRS 501 C 3 designated charitable organization (fund) for the purpose of collecting monies that will be used for humanitarian dental care programs and initiatives in dental education. This decision to seek charitable donations comes from the realization that the ICD is limited in what it can accomplish throughout the world by its financial situation.

Historically, the ICD has kept the International dues for Fellows as low as possible so that the dentists in financially disadvantaged areas of the world can afford to be ICD Fellows. However, the International Council wants to do more to support the projects of the Sections and Regions around the world. Other sources of revenue will be needed. Seeking donations from the public and the profession can be part of



the solution. Cautions will be taken to not interfere with those ICD Sections that have previously established their own charitable Foundations.

### **ICD** Continuing Dental Education

Today, circumstances throughout the world indicate that there is a need for the College at Large (CAL) to play an active role in Continuing Dental Education (CDE). ICD Regions throughout the world have expressed the need for our assistance in educational programming. Initiation (Induction) Ceremonies are often conducted with a CDE program as part of the overall event.



In response, The International

Council decided during its recent meeting in San Francisco that the College at Large shall establish an Office of Continuing Dental Education Programs for the purpose of planning and delivering educational programs of both a nonprofit and for profit nature. It is envisioned that there will be two approaches to CDE initiatives: Indirect- providing support for courses put on by members of the official ICD family, and Direct- actually planning and delivering courses alone, or in collaboration with others.

Fellow John P. Gobetti, DDS, MS, of Ann Arbor, Michigan, USA, has agreed to serve as the Director of Continuing Dental Education. He is a busy, successful and well-known CDE presenter who knows the business. He lives within an hour drive of the new Council Office. In February of 2012 Dr. Gobetti volunteered to present the ICD Seminar in Los Cabos, Mexico. He will be supported in doing the busy work of CDE management by the ICD Council Office.

### **Director of Communications**

This is a new position within the Office of the International Council. It reflects a totally new and expanded approach to College at Large communications.

This position and the management of its duties is something required of all successful organizations. We are delighted that ICD Editor Dov Sydney will take on this responsibility as a part-time staff member providing communication leadership and products. Excellence in this area is critical to the future success of the

ICD, and we are fortunate to have found the right person.

### Welcome to our new Executive Assistant: Chelsea L. White

The daily operations of the new Office of the International Council in Flint, Michigan, USA, will be

the responsibility of Chelsea L. White, whose title will be Executive Assistant to the Secretary General. Ms. White's educational background and work experience are in communications. She achieved an outstanding academic record, graduating from Central Michigan University in Journalism and Media Design. She received high recommendations for her work with the American Red Cross in Michigan. She has made an immediate impact

## ouncil Meeting Highlights

🗨 an Francisco, the city of diversity in ethnicity and culture, Note that was the perfect backdrop for the world-wide gathering of 2012 annual meeting of the International Council this past October. With 122 countries represented by their associated Section representatives and International Officers, this year's meeting advanced one of the most extensive and challenging agendas in the history of the 42 member Council.

### Addressing Council Representation

This important but sensitive issue has been extensively debated both in and out of committee with competing points of view; one being to reduce the size of Council for management efficiency and cost containment, with the other maintaining the influence of each Section's representation proportional with the membership and financial contributions to the College. The ad hoc committee is now focused on developing a concensus and presenting a final recommendation at the 2013 Chengdu meeting.

### ICD Flags and Banners on the Way

Launched in San Francisco and prominently displayed throughout the meeting were the new, official ICD Podium Banners and Flags. They were designed exclusively for the use during ICD events and are being sent throughout the world to all Section offices for distribution to their respective Districts and Regions.

### Focus On Social Media

The Communication Committee Chairman Rajesh Chandna advised the Council that they will be expanding and enhancing the use of all social media, especially Facebook. The committee is also evaluating and translating selected College notices, including press releases, into multiple languages in order to allow easier comprehension for those for whom English causes some difficulty.

### Good News: No Dues Increase

Treasurer Clive Ross noted that good finanicial planning and adherance to the budget has meant that there will not be a need to increase the current individual annual international dues of \$US 35, which are paid by the Sections on behalf of each Fellow.

### Strategic Thinking Session

USA Councilor Keith Suchy moderated three sessions, each touching on current issues of importance to the College.

The first session explored potential cooperation between the College and other international organizations such as WHO and FDI. In addition President Elect Aronson, who led the discussion. described the benefits of collaborating with the Organization for Safety, Asepsis and Prevention (OSAP).

Treasurer Clive Ross chaired the discussion on the Sections' projects that have been successful and those that have not. Lessons learned were

illustrated with presentations by Councilors Phillip Dowell, Donna Brode, Rajesh Chandna, and Antonio Bello who provided a chilling description of humanitarian projects with the backdrop of Mexico's drug war.

In the final session, Editor Dov Sydney reviewed the highly successful all-member communications survey, its implications and how the results are already being used to maintain the quality and access of its print publications while at the same time meet the demand for enhanced electronic media (more on page 10).

### **Legislation Passed**

- The College at Large will seek the approval of the United States Government IRS to be designated as a 501 C 3 organization to support humanitarian programs and initiatives in dental education.
- · The College established an Office of Continuing Dental Education Programs for the purpose of planning and delivering educational programs of both nonprofit and for profit nature.

# EDITOR: How do you respond to those that suggest the College should be small and intimate rather than seeking to increase numbers and influence?

It disturbs me to hear this comment. There is strength in numbers and with thousands of worthy dentists around the world, we will never have to sacrifice quality. Everyone should do their part to encourage growth of the ICD and thereby help keep our College vibrant.

We must remember that since one can only be invited into Fellowship, worthy candidates are at our mercy and are being overlooked. I often see older inductees, some who have authored books or are renowned academicians, and I wonder how many deserving candidates have yet to be recognized. I feel so strongly about this that I believe the Fellowship Pledge should include a commitment to sponsor a worthy candidate within three years of induction.

### As President, you will head a team of fellow officers known as the Executive Committee. What characteristics make you a good team leader?

Jack Hinterman is proving to be an outstanding Secretary General, Treasurer Clive Ross is getting our financial affairs in order and the recent editions of *The Globe* and *The College Today* are evidence of Editor Dov Sydney's ability. All teams need inspiration to do their best job, and I have never been on a team with as much energy, attention to the objectives of the College and concern for the welfare and future of the College as this Executive Committee.

### What three words best describe your vision for the future of the College?

*Growth* in Sections and Regions; *Advancement* of Humanitarian Projects; *Pride* in one's Fellowship.

## What drives you to want to serve the College as President of the College?

While I have never sought the Presidency of any organization including the International College of Dentists, I was always urged to move up in leadership roles.

I was encouraged by College leaders who I greatly admire and respect, many have been my mentors. What drove me the most was that I did not want to disappoint this group by not moving up in the chairs, and hopefully I will not disappoint them or myself. A second point is the fact that someone from a small town in South Georgia was given the opportunity to head the world's most prestigious honorary dental society.

I have also been privileged to attend meetings of Sections I, III, IV, V, VI and VIII. They were all great learning experiences. So based on my involvement with the ICD since becoming a Councilor and my past experience as president of several organizations, I feel that I am prepared for this high honor and responsibility.





### How do you assess the decision to separate the College at Large and the USA Section offices?

I am proud of the fact that I made the motion several years ago for the College to separate from the USA Section. The College was not receiving the attention that it needed and deserved. Also the job of Registrar of the USA Section, Secretary General of the College and Registrar for Section XX was too much for any one person. The administrative needs and oversight for the growth and development of the College at Large and Section XX simply required more time than was available.

I believe that the new Sections and Regions that we are



witnessing and our improved financial affairs are proof that this was a good decision and that this will be realized even more in the years to come.

### What are your personal goals for your Presidential year?

Firstly, I want to stress the relevance of the College at Large and why it is necessary as an umbrella organization for our Sections and Regions. Secondly, we should continue to encourage growth and development of new Sections and Regions, but place equal emphasis on the importance of investing in the growth and vitality of our existing Sections and Regions.

It is our duty, and maybe I should say obligation, to nominate worthy fellowship candidates wherever they may reside in the world.


### Your lovely wife Barbara is seen frequently at ICD events. How does she feel about the heavy responsibilities and demands on your time in the coming year?

This opened many areas of involvement for the USA Fellows. I must take credit for the terms "Developing, Promoting and Recognizing Leadership" and "Be a Leader-Make a Difference".

# WEPLEDGE" INSPIRING YOUNG COLLEAGUES

ection I's White Coat Ceremony is a popular and inspiring project which serves to welcome young colleagues into our great profession of dentistry. Fellows volunteer to serve as hosts, presenters, and moderators at

25 US dental schools, and more programs are added each year. With the opening of nine new US dental schools in this decade, opportunities abound for the expansion of this vibrant program.

### TRANSITIONAL MOMENT

ICD White Coat Ceremonies mark a student's transition from the didactic portion of his or her training to the clinical patient care phase. The ceremonies may differ from one another slightly, but all of them promote ethical behavior, professionalism, leadership, and the pursuit of excellence in service to patients. These are often profound experiences for the students and their families, and their effects can often follow these future doctors far into their professional careers.

### GAR HAGMAN, FOUNDER

Fellow Gar Hagman of Georgia founded this project for the Section in 2002, and chaired the White Coat Subcommittee for many years. Gar's original script, in edited form, still provides the template for many ceremonies. In it he states, "Dentistry is a 'sacred trust' and the obligation of dentists to be ethical, professional, leaders in leadership, morality, mentoring, respecting the achievements from those who have preceded them in clinical practice innovations, research in dental materials, 'never tarnish' the symbolism of the White Coat itself and the importance of being involved in their communities and organized dentistry. I welcome you on

behalf of the ICD to the profession."

Gar's tireless support of this concept has helped make this program a success, and although his term as a Regent ended years ago, he remains a member of the subcommittee.

### The Student's Pledge

Around the country, following the presentation of a volunteer ICD Fellow, in many cases the Dean of the school, the students receive their white coats and then make a pledge as a group.

The following pledge is recited by the University of Washington School of Dentistry students:

"We commit ourselves to the continual pursuit of excellence in all our academic and professional endeavors.

We hereby pledge to: Conduct ourselves with integrity

by upholding and promoting ethical ideals and standards; Demonstrate compassion, empathy and understanding for patients and colleagues; Aspire to leadership through initiative and professional conduct; Maintain a high level of competence through our commitment to learning.

Today we make a lifelong commitment to enhancing professionalism within the practice of dentistry and the entire healthcare system. As students and as dentists, we promise to uphold these principles and dedicate ourselves to the profession."

The Section I ICD White Coat Ceremony is a complement to the beginning of a dental student's career as a doctor, as significant to that stage of training as the hooding ceremony that takes place at graduation.



# **IMPRISONED BUT NOT FORGO**

ne-2-One CAMBODIA is a non-profit organization that aims to provide care to the poor and vulnerable in Cambodia; the orphans, street children, people

with HIV, and prisoners. They seek to meet dental, medical, educational, vocational and physical needs, regardless of ethnicity, gender and religion. The Executive Director is Dr. Callum Durward, a Fellow of the ICD from New Zealand.

### A forgotten minority

During the Khmer Rouge 'Reign of Terror' in the 1970s, Cambodia was left only a handful of dentists and physicians.. Although health professionals now number in the hundreds, most of Cambodia's 16 million people still miss out on any dental and medical care, especially those who are poor and destitute. There is no "free" public health service available, and even hospitals and health centers charge for treatment. With over a third of Cambodia's 15 million people living on less than \$1 a day, even a tooth extraction is a luxury. Prisoners are at the bottom of the heap and represent a forgotten minority that few care about.

The One-2-One prison dental service was established in 2009 and over time has grown to be an important part of our dental program in Cambodia. Our teams are comprised of volunteers, who include One-2-One CAMBODIA staff,

Cambodian dental students, Cambodian dentists and overseas dentists. Apart from the weekly Saturday visits to the four Phnom Penh prisons, our team provides 1-2 monthly visits to provincial prisons – using mobile equipment – usually for five days at a time.

### NO ACCESS TO DENTAL CARE

Most prisoners have dental problems consistent with the general Cambodian population – and many have previously had no access to dental services. Many of the prisoners suffer from toothache and oral infections. Their poor dental health, along with a lack of good nutrition, can contribute to their poor general health. The One-2-One team provides a relief of pain service, as well as providing some basic restorative and periodontal care. The service is received with much gratitude by the prison patients.

One-2-One has formed very important relationships with the Department of Prisons and the Ministry of Health in Cambodia, along with the International College of Dentists and other NGOs, to enable this valuable work to be carried out. Overseas dental students and dentists are welcome to participate in our activities for prisoners as well as other disadvantaged groups in Cambodia.



miles & Hopes Cambodia, established in 2010 under the Global Child Dental Fund, focuses on providing basic dental and medical care to orphans, as well as a one-week basic health and first aid training course for their caregivers. provides the following to each orphan child

enrolled in the program: Relief of dental pain and infection (simple restorations and extractions), de-worming and de-licing, basic personal hygiene – hand washing, nail clipping, hair care, fissure sealants and fluoride varnish – twice per year, toothbrushes and toothpaste and dental health education

The project aims to make a significant difference to both the oral and general health of these children – to bring about a better quality of life. Donors from overseas can choose to support one or more orphanages.

SEAL CAMBODIA, a new Smiles & Hopes Cambodia program, was launched in July 2012. It is co-funded by CamKids – The Cambodia Children's Charity, and the sealant material is supplied free by GC Asia. The project will provide



sealants for 60,000 Grade 1 children over the next three years. The sealants will be placed by Cambodian dentists and dental students, but overseas volunteers are very welcome to come and help. # EAST MEETS VVEST IN DA NANG

n mid April of 2012, the Semiahmoo Dental Outreach Team embarked on a humanitarian trip to central Vietnam. A portion of the funding for equipment and supplies that was brought to Vietnam was kindly donated through the Canada Section's William J. Spence ICD Memorial Foundation. The team of dentists, Drs. Ken Stones, Les Ennis, Lange Soo, Janice Boyd, Joan Eaton and Kevin Gee were accompanied by three dental hygienists, Debbie McDonald, Christine Penn and Candace Leveille.

All travel expenses were borne by the volunteers personally and any funds raised from outside groups went to supplies and direct support of our Vietnamese hosts. The Vancouver based group flew via Hanoi to Da Nang and worked on the ground with a local NGO group, East Meets West, in a remote rural primary school about an hour drive west of Da Nang. The make shift facility had seven portable dental chairs and two extraction tables working full time for five days, all powered by four portable generators and three portable compressors. There were also many portable fans blowing hot, steamy air around in vain, attempting to cool off the Canadians.

For the majority of these children, these were the first dentists they would see and most likely the last. The primary focus was to try to save as much of the adult dentition as possible. The quality of dentistry provided was as one would receive in any dental office in Canada. However, due to time constraints and the sheer numbers of children requiring care, the team was restricted to restorative dentistry and extractions.

This basic dentistry was combined with preventative services such as sealants, and every child seen received topical flouride varnish. Over the five-day period our team treated 409 children with total patient visits of 611. They also performed 1,186 preventative services, 545 fillings and 279 extractions with a dollar equivalent of \$ US 130,950.

Dr. Les Ennis, Fellow of the Canadian Section of the ICD, has spearheaded humanitarian dental outreach clinics for children in both Vietnam and the Philippines.


# A TALE OF TWO FELLOWS IN THE SHADOW OF A VOLCANIC

privilege comes responsibility. This adage permeated through the ICD induction ceremonies, recently experienced by Dr. Scott Podell (USA Section) and Dr. Coretta Fergus (International Section) when they were honored with Fellowship. Dr. Podell serves at the largest dental school in the USA. Dr. Fergus is the only dentist in the British Overseas Territory of Montserrat, West Indies, approximately 300 miles east-southeast of Puerto Rico. They had little in common until an erupting volcano brought their privileges and responsibilities together.

### SOUFRIERE HILLS VOLCANO RUMBLES

Dr. Podell first visited the island of Montserrat as a volunteer dentist in the late 1980s. Then in July 1995, the Soufriere Hills volcano unexpectedly rumbled to life and began an eruption, which continued over the next few years. Most everything in Plymouth (the abandoned former capital), including the hospital, became buried. Eventually the southern half of the island was rendered uninhabitable. Roughly two thirds of the population (approximately 8,000 people) left the island due to economic and housing disruption, and just about all major industries and services, including the dental service, were forced to begin anew to care for the remaining population. Podell began searching for a way to contribute toward the rebuilding of the dental service. A few isolated projects of support were undertaken while care was being delivered through an interim dental clinic. Eventually, a modern dental facility was completed, and Dr. Coretta Fergus, a native Montserratian, was appointed as the new government dental surgeon. They met in 2005, and since then have partnered to enhance the level of oral health care on the island.

### MEETING THE CHALLENGE

The professional lives of Drs. Podell and Fergus are diametric opposites. Podell is based at New York University College of Dentistry in New York City, where he has countless dental practitioners to consult with and organizations to seek assistance from. Dr. Fergus, on the other hand, practices in isolation. Their collaboration has a simple theme: furnish Dr. Fergus with the resources to allow her to elevate the level of the care on the island.

> Dr. Fergus updates Dr. Podell on items sorely needed for the proper provision of treatment and maintenance of the homecare program. Podell, in turn, conveys this information to dental supply companies in the States. Many of these companies have established donation programs to lend assistance; others have been so intrigued by the Pompeii-like destruction of an island that they are moved to learn more. Each passing year brings an increasing number of institutions who generously donate supplies.

### CONSULTATION SERVICE

In an effort to relieve the burden of practicing without the benefit of consultations and second options, Drs. Fergus and Podell established an electronic consultation service. She is able to review cases with various faculty members at NYU College of Dentistry utilizing a state of the art digital camera. Communication between Montserrat and NYUCD is facilitated through a computerized consultation form developed by a former Podell NYU student, Dr. Jordan Blank. This service allows Dr. Fergus to do something that most take for granted - discuss cases with other dentists.

# TREATING ROOTS of a DIFFERENT KIND

n 2009, the Philippines suffered its worst ever calamity in recorded history. Rampaging waters in the metropolis flooded and left thousands dead and homeless, with some areas submerged in flood waters for three months due to senseless and illegal logging of trees in its mountain ranges.

President Benigno C. Aquino III saw an urgent need for reforestation to save the country and its environment and thus created the National Greening Program, the goal of which is to have 1.5 billion trees planted by 2016. ICD Philippine Section seeing the urgency and the direct benefits of re-plantation, including saving our children from future devastation, launched a tree planting mission as their contribution to save the environment and the country.

Tanay, a scenic province of Rizal in Southern Luzon with a big watershed bound by the Sierra Mountain Ranges, found the ICD Philippine Section (with the assistance of the Armed Forces of the Philippines) planting an initial stock of more than 600 trees of different varieties indigenous to the Philippines, as well as the area of La Mesa Dam in Quezon City, one of the biggest reservoirs supplying the major cities of Metro Manila and the province of Bulacan in Northern Luzon.

# Collaboration with Kothiwal Dental College

ver 8,000 school children of Moradabad were evaluated for severity of malocclusion and the need for orthodontic therapy. ICD Section VI's School Dental and Orthodontic

Program was organized in cooperation with the Kothiwal Dental College, Moradabad (INDIA).

Between January 2011 and June 2012, 261 patients in the group consisting of early adults and adolescents were evaluated and extended services for orthodontic treatment. One hundred and seventy one patients were treated with removable and functional appliances, free of charge, and 80 more were treated with fixed orthodontic appliances using Edgewise appliances and pre-adjusted (Roth & MBT) appliances. In this category the charges were less than US \$100 or 5,000 R's. Following the treatment, 48 patients were placed on retainers. The School Dental Health Need Assessment Program began in September 2012.

Our goal is to complete the evaluation of 10,000 school children to determine their total dental needs and provide for the management of their orthodontic problems.

# OFF THE STREETS

aul Becker and his wife Tania began helping Odessa street children in 1999 after realizing that most of them had fled terrible conditions in state orphanages. Various tutors, psychologists and additional supervisors joined them. The children, ages 8-18, enjoyed weekly field trips and weekends were spent in the Becker's home. The new dental suite was built to treat 350 children inside the orphanage.

ICD Europe and USA Sections played an important role in this project providing dental and medical needs. Over the last six years, renowned ICD professors have visited Ukraine to teach health workers. The ICD assisted in the construction of dental facilities at the orphanage and a children's TB sanatorium in addition to supporting outstanding dental care by welltrained dentists. Routine six-month dental prophylaxis were

introduced to this greatly underserved segment of society, which continues to benefit from the generosity of the College and its Fellows.







Once again, the Board approved the granting of 10 student awards of \$1000 each plus a plaqued certificate to each award winner in the 10 Faculties of Dentistry in Canada. We are planning to expand the functions of the website and to follow the lead of the Council at Large in this area.


- Speroway Project received \$8,000 to provide volunteer care in Haiti and Central America.

# Working with Local Authorities and University

# International Activity

# Communitary Service in Yucatán

The Southern Regency, under the guidance of Regent Dr. Rolando Peniche, once again organized their annual "Dental Brigades".

July 30-31 and Aug. 1, 2012, were the dates in which the event took place in the rural zones of Baca, Mocochá, and Hacienda Tekat in the state of Yucatan, and for three days dental students and teachers from the Universidad Anáhuac Mayab, in conjunction with Fellows from the International College of Dentists and with the help of Foundation Luis Seiquer from Spain which brought teachers and dental students from Universidad de Sevilla, worked together treating dental patients without any charge as part of an academic exchange between these two universities. Working together, the students, teachers and ICD Fellows successfully treated 300 patients in mobile dental units, bringing this important service to a rural zone that has no possibilities of dental attention.

## Section Founded 30 Years Ago

S ection IV South America was founded in 1981, reaching 30 years of operation within the organization. Of the 10 countries that are part of the region, six of them are actively participating in the International College of Dentists: Argentina, Brazil, Chile, Paraguay, Peru and Uruguay.

The other four countries (Bolivia, Colombia, Ecuador and Venezuela) are currently not participating in the group; however, we are working with them, respecting their own features, customs and laws, so they can once again become Districts of the College and participate in our activities as members of the South American Section.

Currently, the South American Section features 222 active Fellows and 44 honorary Fellows, reaching 286 members.

## Section/Region Annual Meetings and Induction Ceremony

The South American Section's Annual Regents Meeting took place in Montevideo, Uruguay, on Sept.13-14, 2012. It was Section IV's 31st Annual Regents Meeting, and it was attended by representatives from Argentina, Brazil, Chile, Paraguay, Peru and Uruguay, as well as by the members of the Section's Executive Committee. It was perfectly organized by the Uruguayan District, which provided a warm welcome together with a fraternal spirit, making this event a time of great friendship and cordiality.

The meeting was chaired by the Section's President, Fellow Alvaro Gadola. Officers and Regents presented their

## **District Projects**

#### Argentina

Training Programs are being developed for Early Detection of Oral Cancer under the supervision of Dr. Rafael Gutierrez, who informs at a professional level the characteristics of this pathology. Dr. Gutierrez is the head professor of Stomatology and Director of the Center of Prevention and Detection Center of Oral Cancer at Maimonides University, Buenos Aires, Argentina.

#### Brazil

In May, the Brazilian District organized the course "Oral Cancer and the most common Oral Illnesses", by Prof. Halbert Villalba in the city of Sorocaba. In addition, a Patients Care Program is being developed, called: "Oral Prevention in Kidney Transplanted Patients from 5 to 20 years old", through an agreement among the International College of Dentists (ICD), the Brazilian District, the Paulista University and the Paulista College

of Medicine. This Program has given service to 72 patients, 31 of them transplanted.

The Brazilian District is on its way to place ICD as a representative entity at a dental level in Brazil, trying to increase its number of associates, but also keeping the high level of its members.

#### Chile

The District meeting has taken place monthly, and it was established to propose three motions at a South American level: Propose doctors Jose Matas Colom and Raul Corvalan Bucher as Master-Fellows, and propose the organization of the First South American Odontology Congress of the International College of Dentists in 2013, and propose a title of Councilor-Assistant to properly introduce a new Councilor in the future (2016).

Seven new members have joined in order to rejuvenate and increase the District.

Section IV Honorary Fellow Donald Johnson was proposed for The Ottofy Okumura Award.

#### Paraguay

The Paraguayan District has 18 Fellows. It has focused on scientific training commitment and the updating of odontologists. It has established long and medium term stages in its educational project for the active participation of its Fellows, in both national and international events.

There is a Continuous Education Program for school students, an agreement between the Odontology Faculty of the National University in Asunción and Colgate. Services are provided to rural schools and in October 2011, a Prevention Fair was held with more than 1,200 people attending.

The District participates actively in helping the community, especially the most vulnerable sectors of society.

#### Peru

The Peruvian District is being restructured under the supervision of Dr. Freddie Williams, who is also in charge of organizing the South forward to. Regarding communications, the Section will revitalize its website and publication.

Each District made a presentation of its activities and future plans, increasing the interest of the Section in Continuous Education, which is highly welcome by South American Fellows. Based on this interest, the idea of organizing the First South American Congress of the International College of Dentists came up. It will probably take place in Montevideo, Uruguay, during 2013.

Furthermore, the South American Section expressed its wish to participate in the Central Committees that consider Continuous Training and the Students Exchange. The list of three candidates for Master-Fellow was approved: Dr. Matas and Dr. Corvalán for Master-Fellows, and Dr. María Elena Barañano for Master-Fellow-Emeritus. During a rainy afternoon, the Investiture Ceremony of 19 new South American Fellows was held.

# Activity Days in Chile

This year, the Chilean District has focused on training activities and has organized two activity days called: "Controversies in Odontology", in November 2011 and May 2012. This activity consisted of introducing a topic that was not totally defined by the dental profession. The first topic to be analyzed was: "Which should be the initial jaw position to start a rehabilitating treatment?", and the second topic was: "Restoring of the Front Part: Odontology or Cosmetology? Technique, Ethics and Aesthetics".

These meetings took place under the following system: Four remarkable specialists from different areas were invited (Maxillofacial Orthopedics and Orthodontics, Maxillofacial Surgery, a TMJ specialist and an Oral Rehabilitation specialist). The speakers were given 30 minutes to explain their point of view of the topic and then the audience was able to ask questions to the experts, making the meeting much more interactive. Afterwards, and thanks to the participation of final year

Odontology students from Chile University, it was possible to send to all the participants the transcription of all the topics covered during the meeting.

#### **Projects and Funding**

The term of this post will be three years. Dr. Mahesh Verma was elected as the first Chairperson.

There were 2,300 removable appliances and 85 fixed functional appliances that were given, free of cost, for intercepting and

modulating the growth in patients between ages 8 and 12. These patients were from poor economic backgrounds and were chiefly females, who were further extended to fixed orthodontic treatment at the cost of US \$99 or Rs 5000.

Kothiwal Dental College started another ICD project as the School Dental Health program in Moradabad to identify Dental needs and render preventive, interceptive and corrective dental measures, taking a hold of dental diseases with the help of Dr. D. N. Kapoor. This was achieved by faculty and graduating students assessing 10,000 school children between ages 8 and 15, and offering them free orthodontic treatment. This College is committed to continue free dental services to all those who are in need of dental service,

- The ICD is scientific partner to the Famdent, held its first meeting at Ahmedabad. A very successful meeting was held at Mumbai. Dr. Rajiv K. Chugh, Registrar VI, inaugurated the conference at New Delhi.
- "Revising, Enhancing and Standardizing Periodontal Postdoctoral Education In India", a PG teachers training summit partnered by the University of Stonybrook, USA, and MUHS in a unique program.
- Workshop on 'Future Road Map' was held on August 25, 2012, by the ICD Section VI in association with the A. B. Shetty Memorial Institute of Dental Sciences at Mangalore.





# In Memory of Dr. Neil Henry AM 1929 - 2012

Dr. Neil Henry AM passed away peacefully on July 11, 2012, having practiced as a general dentist for over 50 years in the Wynnum area of Queensland. # ICD –GK (Gawad Kalinga) Partnerships

#### The ICD GK Partnership has undergone major breakthroughs for the year 2012.

President Marilyn Leung and Fellow Fatima Dizon, Chair of the ICD-GK Project, presented the ICD-GK-PDA (Philippine Dental Association) Partnership to 50 Chapter and Affiliate Society Presidents of PDA on May 15, 2012, at the PDA Building. The main objective of this ICD-GK collaboration with the PDA dental chapters and dental schools is to initiate and train GK volunteer health care workers in dental base profile collection of the community and to get the assistance of PDA members to provide preventive and restorative dental treatments to over 2,000 GK communities all over the Philippines.

#### Bataan Community Program

The ICD-GK Bataan Community Program, which started in Sept. 16, 2009, with brothers/ Fellows Felipe and Primo Gonzales donating a three-hectare property in Bagac, Bataan, allocated for 100 homes, a school, a multipurpose hall, a medical-dental clinic, a livelihood and agriculture program. To date, donations for 10 houses have been received. For the Medical Dental Clinic, a donation of US \$5,000 was received from Mr. Anthony Volpe of Colgate, USA, through the efforts of our Councilman Fellow Primo Gonzales. Target construction date is December 2012. This will be a continuing project of the ICD until the completion of the project.

# The Regions of Section XX Building Blocks of the College

The year 2012 was remarkably progressive for the Regions of The College who are organized and administered under the ICD's International Section XX, by the International Council and the Council Office. There was much enthusiasm expressed for the ICD across several Regions that experienced new growth and renewal. This bodes very well for the future of the College worldwide but also increases the responsibilities of the College at Large to assist its growing family.

#### Alternate Paths To Fellowship, Region Building

It has been a long standing pattern to establish the College in new areas by relying on an ICD Fellow to act as a mentor from outside the country, or to find a local advocate from inside the country to recruit at least 15 candidates for Fellowship. With 15 candidates, the group would qualify to form a Region, have an Initiation (Induction) Ceremony and become ICD Fellows. There is now an alternate pathway. Where the traditional approach is not possible, the International Council has recently authorized the Secretary General to admit gualifying candidates directly to Fellowship, one at a time, and to arrange the Initiation Ceremony later. The ICD is often contacted by dentists who seek Fellowship, but no local path is open to them.

#### New Fellows, New Leadership

A record number of 165 new Fellows were inducted across the ICD Regions in 2012. Two new Regions were chartered (West Africa and Kazakhstan), and one Region was reactivated (Vietnam). In these instances, excellent and enthusiastic new leaders stepped up to guide the future fortunes of the ICD in areas where it was not functioning previously. There is much potential for the ICD in the South East Asia Nations (SEAN). Successful Initiation Ceremonies were held in three other wellmanaged Regions (Iran, Malaysia and Hong Kong). There are now seven active ICD Regions who are maintaining a progressive course of local growth and communicating with the worldwide ICD family. In the new Regions, the gifted, enthusiastic Regents who have stepped forth are esteemed members of the local dental community. The ICD is getting the "best of the best" that dentistry has to offer. It is important that we do what we can to support them. Because of them, it is not an exaggeration to predict Section XX will become the ICD's second largest Section in just a few short years.

## **Granting The ICD Charter**

The Secretary General has begun the process of granting, or renewing, the official ICD Charter given to each Region in International Section XX. This involves a formal process of developing an organizational plan and installing an officer corps for each Region. Efforts are made to reach a clear understanding between all parties as to respective duties and responsibilities. Future projects and programs within the Regions are also discussed. Every effort must be taken to maintain the momentum and excitement Fellows feel when they first become an ICD Fellow. Most times Regions do not charge local dues and cannot afford local programing. As a result, Regions may become inactive and Fellows drift away and loose interest.

It is now required of an ICD Region:

- To maintain an updated roster of the Fellows and provide a copy of it annually.
- To conduct an Initiation Ceremony for new Fellows at least every other year.

Region 33. The Regent works alone without other officers. No local dues are assessed out of fear of losing members. Without funding, local programing is not possible. Over time, Fellows fall out of their good standing and stop paying international dues because they lose interest and enthusiasm. Occasional Initiation Ceremonies are held in order to maintain membership levels.

During their April 2012 discussions, Regent Yim asked whether the Secretary General had come to fire him. On the contrary, Secretary General Hinterman told Regent Yim that he was appreciated by the ICD for his loyal service, especially true in light of the fact that assistance had not been provided to him in the past by the ICD world headquarters. ### Region 31 VIETNAM An Enthusiastic Renewal

Ho Chi Minh City, Vietnam, was the setting for a spectacular rebirth for ICD Region 31 Vietnam in April, 2012. The event was hosted by Vietnam's leading Dental School, the Faculty of Odonto-Stomatology. Seventy-seven new and returning ICD Fellows were welcomed into the International College of Dentists by Secretary General Jack Hinterman. A wonderful banquet with entertainment topped off the full day of programming, which included a morning workshop for dental educators.

ICD Region 31 was founded in 2001 through the personal efforts of Dr. Herbert Yee, who was then the International President of the ICD. Twenty-four dentists were accepted into ICD Fellowship at that time. Over the years, Region 31 became separated from the College and slipped into a state of inactivity. In recent years, International Past President Manfred Seidemann took an interest in Vietnam's revitalization and reestablished a working relationship with leaders in the academic community. He was assisted in this by ICD Fellow Hein Ngo, who was born in Vietnam but now resides in Australia. Through their persistence and guidance, Associate Prof. Le Duc Lahn, Dean of the Faculty of OdontoStomatology, was persuaded to approve and sponsor the Initiation Ceremony. The School's Assoc. Vice President for International Affairs, Dr. Hoang Trong Hung was the key organizer of these events.

#### **Initiation Ceremony**

Of the original 24 "founding" Fellows of Region 31, 19 are alive today and all of them have renewed their ICD Fellowship. Their leadership in this regard inspired 58 additional dentists to accept the extended hand of ICD Fellowship during the ceremonies from Secretary General Hinterman. # A Historic New Beginning for ICD in Africa

The ICD Section XX Region 34 (West Africa) was initiated in a colorful inaugural and charter-granting ceremony on January 21, 2012, at the Ghana College of Surgeons and Physicians, Accra Ghana. Secretary General Dr. John Hinterman conducted the ceremony, which was sponsored by the Co-chairman of the International Congress of Oral Implantologists, Fellow Ken Judy. The ceremony was attended by several dignitaries from Ghana including the Vice Chancellor of the Kwame Nkurumah University of Science and Technology, Prof. Peter Donkor, also a dentist. The Rector of the Ghana College of Surgeons and Physicians, Prof. Oforieje, represented the Ghana Minister of Health at the Initiation Ceremony.

The ICD Councilor (Jamaica) Chris Ogunsalu and Fellow Ambrose Obiechina sponsored the 37 candidates who were inducted. This comprises 22 Fellows from Nigeria, 12 from Ghana, and one each from Cameroon, Kenya and the Caribbean.

The Induction Ceremony was preceded by a Continuous Education Program (CPED) on implants, given by Dr. Ken Judy and Fellow Chris Ogunsalu.

Secretary General John Hinterman conducted the initiation and charter-granting ceremony, which was followed by a reception and dinner at the Movenpick Ambassador Hotel.

Leaders were appointed for the new Section; Fellow Ebenezer Nyako and Ambrose Obiechina were appointed Regent and Deputy Regent respectively. Fellow Gbemisola Agbelusi was appointed the Councilordesignate for Africa.

Shortly after the Induction Ceremony, a Facebook page was opened by the Councilor – designate, which included all of the ceremony photographs. The Facebook page has been active, with pictures from various programs of the sector being posted regularly.

Membership drive into the ICD has since commenced fully in the Africa Sector, with the completion of nomination forms by 11 dentists in Nigeria and five from Kenya for initiation in 2013. The Secretary General has been helpful with the membership drive in Africa, making contacts in Egypt and Sudan. The 2013 President Leon Aronson has taken a personal interest in chartering a new Region in South Africa. Efforts are also ongoing to recruit members from Tanzania and Uganda.

On July 7, 2012, the Vice Regent for Region 34, Fellow Ambrose Obiechina, resigned citing reasons of "incompatibility". This is a big blow to the young Region as he is the only ICD official in Nigeria, apart from the Councilor-designate. I will seize this opportunity to suggest that members should be appointed to run the affairs of each country in Africa; this will make for a more robust participation in the affairs of the College.

ICD Fellows in Lagos state partnered with the Faculty of Dental Sciences, College of Medicine of the University of Lagos, during the 6th Annual Scientific Conference of the Faculty

# The ICD Evolution

The story of the farewell gathering for Dr. Louis Ottofy in Tokyo, 1920, where Dr. Tsurukichi Okamura planted the seed for the International College of Dentists, is well-documented. During the next eight years sufficient progress was made that a permanent college, international in scope, was established and incorporated – a place where cordial relations among dentists in all parts of the world could be fostered and valuable data pertaining to dentistry assembled and made useful to all, even those in the less populated areas.

At that time the official Constitution was a brief document, occasionally revised until in 1938 it contained a list of 10 Objectives of the College. The thrust of these objectives was toward the growth and diffusion of dental knowledge and clinical practice.

From the lists of memberships in various histories it appears that Fellowships, although selected on a merit basis, were conferred on members of the profession who were prominent in dental organizations and/or dental education. The dissemination of dental knowledge was first and foremost.

Over time, as communication was expanding through the medium of television and world travel was increasing by leaps and bounds, the more affluent segment of society was becoming more aware of how the 'other half' lived.

How so many people in the economically underdeveloped parts of the world had little or no access to even the most basic dental care and how rampant dental disease was in the poorer segments of the world's population. Gradually, the Fellows of the ICD began to pay attention and tried to do something to alleviate this situation.

By the turn of the century, consideration was being directed towards this end. Some Sections had already initiated projects, through ...the philosophy of the College was changing along with qualifications for Fellowship. In some Sections record of service is now equally important as involvement in the profession.



organizations such as Section XII's 'Taiwan Root Medical Peace Corps,' USA Section's 'Kikiyu Dental Clinic' in Kenya and Section V's 'Dentists Without Frontiers,' based in Madrid, Spain. In 1992, Section II (Canada) sponsored the first of its multitude of humanitarian projects by supporting three of its Fellows for a mission in Honduras. Foundations to assist with the funding of humanitarian projects were established by the USA, the European and the Canadian Sections.

The philosophy of the College was broadening as changes were made in our aims and objectives. In 2000 the International Council adopted a new Mission Statement and the Motto: "Recognizing Service as well as the Opportunity to Serve." Listed along with the other Goals of the College – Leadership, Recognition, Education and Professional Relations, was Humanitarianism to "Foster measures for the prevention and treatment of oral disease by encouraging and supporting humanitarian projects."

The qualifications for invitation to Fellowship were likewise changing. In some Sections, the prospective Fellow's record of service to his/her community is now equally important for acceptance as his/her involvement in the profession. This is in keeping with our new motto.

During the past several years the Section reports in *The Globe* have increasingly reported humanitarian projects sponsored and funded for the most part by the generous donations of the Fellows of the Section leading and most recently the introduction of the the *Impact* segment in 2012 issue featuring humanitarian projects carried out by a majority of our Sections. These all illustrate the evolution of the International College of Dentists.
